#### Background

Despite a longstanding commitment by the humanitarian community to meet the needs of the vulnerable people living in South Darfur State, the targeted populations continue to be underserved in regards to basic services including clean water, adequate sanitation and health care etc .... Furthermore, the local government structures and local communities do not presently have the capacity to sufficiently address the urgent needs of the growing population and are heavily reliant on Federal or external support to do so. Consequently, although special attention is still required for key activities to meet the needs of the IDPs in camps with a combined estimated population of 800,000, the proposed programs includes a transition strategy that will work towards building capacity and moving service delivery over to the Sudanese government offices, while responsibly phasing out service delivery in the areas of return and camps. Building on current programming in the sectors listed below, NaHA proposes a multi–sector programs that will target water, sanitation and hygiene (WASH), health care, Agriculture and Animal Resource, in addition to Education, Environment and Non Food Items (NFIs).

The proposed project aims to directly improve the overall health and wellbeing of an estimated 1,000,000 spontaneous returnees and individuals living in vulnerable host communities, thus enhancing the conditions and opportunities required to enable early recovery along the South Darfur corridors with an estimated population of about 2,000,000 including IDPs in camps. NaHA will continue to focus on building local capacity through training and community engagement, with a special emphasis on children, gender, protection mainstreaming, and inclusion of persons with disabilities through all sectors of the project.

#### What is NaHA

National Humanitarian Aid (NaHA) has been committed to immediate humanitarian relief to support those in urgent need and protect people's dignity, while co-creating longer term opportunities for sustainable growth and fulfilling people's potential.

NAHA is national non-governmental organization (NNGO), non profitable and non religious established in 2013 and registered in the Humanitarian Aid Commission (HAC). NaHA has started as humanitarian NGO working with social activities providing Muslim food items ( Audhya ), mosques construction and

rehabilitation, hand pump maintenance and school classrooms in camps with local materials. All these projects funded by privet Muslim donors from Turkey, as well as orphan care.

The WASH sector since its establishment in 2013, NAHA has successfully implemented many WASH projects through partnership with World Vision international Nyala office, mainly in Kass and North Nyala and currently executing a WASH project that funded by World Vision International, which is responding to fill the gap in South Darfur; while there is other sectors provides Agriculture and Animal Production services. In addition to Heath care, the services that goes to IDPs through Memorandum of understanding (MoU) with Sudanese Turkish Hospital Nyala.

Implementation was in the same areas of operation in South Darfur. Below table indicates the funding agencies (donors), project dates, funding amount, projects locations and relevant sectors/sub-sectors.



- Employees can retain the right to make alteration and additions if required by circumstances.
- The employee is obliged to keep in good condition any materials entrusted to him/her for work purposes.
- NaHA is committed to providing a work Environment that is free from harassment, thereby promoting the dignity and equality of the human person therefore all employees should understand and respect the policy, and sign on the Harassment paper document.
- Child Protection Policy subsist on 2015 to be signed by all NaHA staff, volunteers Interns, Visitors, Media, Contractors, Suppliers, Donors, Sponsors and with individuals who get into contact with children in a NaHA program (Similar to WV child Policy)

#### - Human Resource

NaHA has established and approved labour low matching to Sudan Government national labor low contains details and condition of employment and it has the duties and rights of all employees working with NaHA.

The present low, rules and regulation will take effect ass of 2015, they are integral part for all individual employment before signing their employment contract with NaHA they should read, understand and become familiar with internal regulation.

#### **Finance Sector**

Finance is one of the basic sectors headed by qualified staff gained there experience and through the long partnership with many different donors and international NGOs, NaHA succeeds to develop finance system in terms of policy, formats, and book keeping and all senior staff should go through and understand and fallow the rules and finance instructions.

#### Coordination

NaHA committed to coordinate with line ministries, community leaders and the other relevant stakeholders in addition to UN agencies, international nongovernmental Organizations (INGOs) and National nongovernmental Organization (NNGOS), therefore NaHA attend all coordination meetings related to activities and to share its experience with the humanitarian actors on the ground especially with the main forums of Coordination

- Muslim Hands International UK Sudan Office donated water project at South and West Nyala Town New construction and rehabilitation of Hand Pumps and Motorize pumps with aprons

#### Health

 Partnership with Sudanese Turkish Hospital to provide medical services to IDPs camps in Nyala where NaHA facilitate to get approval from HAC and Ministry of Health to cover the cap due to quitted INGOS. This let NaAH registered the patients and then transporting them to the hospital, seeing the Doctors, investigations, medical treatment, having meal and back to camps for free to all IDPS during 2016 and will continue.

Government Line Ministries

 Partnership with all Government Sectors and community in all stages of implementation to promote processes base on the optimization of the resource and the quality of the work to achieve the best and to have positive impact.

#### **Logistic Manual**

NaHA has created Logistic Manual (attached with the profile) matching the needs of the activities and similar to the Partner systems to support the staff achieving their activities in appropriate way.

Logistics has the responsibility of maximizing the use of the resources it has received from donors and ensuring that the materials and works/services it acquires are obtained in an effective, equitable and economic manner and in compliance with established and accepted standards of conduct governing the awarding and administration of goods and works/service contracts and /or grants.

The success of any system depends on the use of appropriate and consistent policies, procedures, and guideline that ensure proper accountability to itself and its benefactor(s). It is also contingent upon clear, accurate, and effective communication, be it between individuals and departments within that system or between the system itself and outside parties. National Humanitarian Aid Organization (NaHA) program is no executed in the spirit of these virtues, which are aimed at being unswervingly accountable to its beneficiaries and donors.

Herein contained therefore, are the standardized logistics and procurement procedures categorized into 5 (five) major sections. These polices and guidelines are consistent with minimum logistical standards provided by NaHA, and are reflected of unavoidable country – specific realities. The five major categories include:

- 1- Procurement
- 2- Warehouse
- 3- Asset Management
- 4- Vehicle Management
- 5- Notes on policy Revision and management

This polices and guidelines will apply to all staff (local staff & expatriates) employed by National Humanitarian Aid Organization, at all field localities. They principally aim at:

- Ensuring that the logistics department delivers the right supplies/works/services in good time, in the right quantities, at the right place, at the right price and in the right condition.
- Providing a framework through which salient issues are clarified to all staff.
- Reducing over dependence on individual judgment.
- Creating consistence in operations.
- Communicating management position to all the staff.
- Creating clear responsibility.
- Promoting transparency.

This manual may be reviewed on a yearly basis to make the required change to suit revised instruction from NaHA Executive panel or changed condition in country.

#### **Child Protection Unit**

NaHA Board of Directors agreed to develop Child protection policy in cooperation with the partners who have long experience in this field, in the same time all NaHA's staff, Volunteers, Interns, Visitors, Media, Contractors, Suppliers, Donors, Sponsors and with individuals who get into contact with children in NaHA program should sign in the course of their association with NaHA, they will track the guideline below as we did with partners (WVI):

- 1. Treat all children and young people that I get into contact with in the course of my work/visit with respect regardless of race, color, sex, language, disability, religion, political or other opinion, national, ethnic or social origin, birth or other status.
- 2. Provide a welcoming, inclusive and safe environment for all children, young people, parents, employees and volunteers in the program area.
- 3. Encourage children, young people, parents, employees and volunteers to speak up about issues that affect them in the course of my work.
- 4. Refrain from using corporal punishment on children.
- 5. Immediately report concerns or allegations of child abuse in accordance with NaHA's reporting process.
- 6. Comply with local, national and international child protection laws.
- 7. Ensure that, whenever possible, another adult is present when I am working with children, or in the proximity of children

#### And I will not:

- 8. Use inappropriate language whether of an offensive, discriminatory, demeaning, abusive or sexual nature when speaking with or whilst in the presence of a child or young person
- Engage in behavior to shame, humiliate, belittle or degrade a child or young person, or otherwise emotionally abuse a child or young person
- 10. Marry a person under the age of 18

- 11. Act in a sexually provocative manner or engage children in any form of sexual activity, including paying for sexual services
- 12. Hold, kiss, cuddle or touch a child in an inappropriate, unnecessary or culturally insensitive way
- 13. Condone or participate in, behavior with children which is illegal, unsafe or abusive
- 14. Discriminate against or in favor of particular children to the exclusion of others
- 15. Spend time outside work requirements with any child or young person connected with NaHA's programs
- 16. Hire children for any labor which is inappropriate for their age or development, interferes with their education or play, or places them at risk of injury
- 17. Do things for children of a personal nature that they can do for themselves such as toileting them or changing their clothes
- 18. Sleep in close proximity to any children during NaHA activity unless it is absolutely necessary, in which case I will keep my supervisor/manager informed and ensure another adult is present, where possible (noting that this does not apply to my own children).
- 19. Access or create sexually abusive images of children, and
- 20. Use computers, mobile phones, video or digital cameras or any other technology for the purpose of exploiting or harassing children.

#### Before photographing or filming a child for work related purposes:-

- 21. Assess and comply with local traditions or restrictions on reproducing personal images
- 22. At a minimum, obtain and document verbal consent from children and/or their parent or guardian and explain how the photograph or film will be used. Written consent should be obtained, where possible
- 23. Ensure photographs, films, videos and DVDs present children in a dignified and respectful manner and not in a vulnerable or submissive manner.
- 24. Children should be adequately clothed and not in poses that could be perceive
- 25. Ensure images are honest representations of the situations and the facts
- 26. Ensure the identities of children and young people in photographic and electronic images are not disclosed
- 27. Ensure these files are stored securely and access is limited on a needs basis to relevant staff only.

The National Humanitarian Aid (NaHA) is a national nonprofit organization that has provided humanitarian assistance to thousands of beneficiaries over the past years. NaHA works with IDPs and affected communities in South Darfur, helping people regain control of their lives. NaHA is seeking support from Donors because of a long-standing, effective partnership, and because NaHA's goals are in line with the Donor's mandate to alleviate human suffering and reduce the economic and social impact of humanitarian emergencies and development.
